

# Women's Giving Circle of McKean County

### **Application and Guidelines**

### **Application Deadline is September 22, 2023**

The Women's Giving Circle of McKean County is a society of philanthropists who work collectively to address and support issues that are important to women.

- Awards may be considered for new projects, or to enhance well-established programs. Priority will be given to projects that support issues that are important to women and enhance the quality of life for families in McKean County. Awards may also be considered for start-up funds.
- Awards are limited to tax-exempt organizations, including nonprofit organizations in good standing, as defined by the Internal Revenue Service Code Section 501(c)(3), schools, or municipalities.
- Organizations may apply for funding annually. Projects will be funded for one campaign only, unless there are extenuating circumstances.
- Requests must not duplicate the work of other local organizations, and must prioritize sustainability. Projects that work cooperatively to support community efforts will be considered.
- Awards to individuals are not eligible. Capital campaigns or endowment funds are not typically considered for funding.
- Requests for award amounts up to \$2,000 will be considered. Awards of less than the full amount requested may be granted. Matching funds may be required as well as challenge grants for additional funding.

Applications will be reviewed and recommended to the full membership for consideration based on the following criteria:

> Eligible organization Meets targeted need as indicated Quality of the Project

Number of individuals receiving direct services Indirect community impact Execution plan for management of the project

Selected grant applications will be presented to the full membership at its annual meeting in the fall. Each applicant chosen as a finalist will be asked to provide a short presentation. Presentations will provide an opportunity to bring awareness to the services provided, as a benefit to the applicant and membership. Successful awardees will be encouraged to share success stories and to engage in future promotional public relations. Depending on the venue, a video presentation maybe requested.

#### INSTRUCTIONS FOR SUBMITTING A GRANT APPLICATION

- A. Fill out the enclosed GRANT APPLICATION FORM and Summary.
- B. Narrative should be a maximum of two pages, 12-point font with one inch margins that includes the following information. Please provide your information in this order, using the outline.

#### 1. Organization Information:

a. Brief summary of organization's history, mission and goals.

#### 2. Purpose of this Grant:

- a. Describe the program/project, the need(s) it will address and what it will accomplish.
- b. Is it a new or ongoing program/project of the organization?
- c. List the program/project goals, objectives.
- d. Describe the timetable for this program to be completed.
- e. Do other organizations provide services/programs similar to your program? If so, why is it important that your agency also provides this service?

#### 3. Budget Information:

- a. State the exact dollar amount of program/project budget being requested on the Budget Statement
- b. Describe how you would modify your project with partial funding.
- c. What are the long-term strategies for funding the program/project beyond the grant period?
- d. The project and evaluation submitted to Women's Giving Circle of McKean County must be completed within one year of receiving the grant. Please note that receipts will be required for all grants awarded.

#### 4. Summary:

Provide a brief overview that will be sent to the Women's Giving Circle of McKean County membership in advance describing the project. This should not be more than 200 words long.

The applications recommended to the membership will be based on:

- Eligible organization
- Meets targeted need as indicated
- Quality of the project

- Number of individuals receiving direct services
- Indirect community impact
- Execution plan for management of the project

#### Please be sure to address these issues in your narrative.

Recommended grant applications will be presented to the full members of WGC at its annual meeting in the fall. Since the venue this year being planned for a in person event, we are asking for a representative prepare a brief presentation. This will be your opportunity to promote the project to the membership for their vote.

In addition, successful awardees will be encouraged to document their success stories, for future promotional public relations.
